

WAYAWAY DISCOUNT FOR THE FIRST YEAR PROMOTION RULES

Version No. 2.

This version comes into force on August 10, 2022

1. Name of the Promotion

"WayAway discount for the first year" (hereinafter referred to as the "Promotion") is a stimulating action, which is a set of activities, the purpose of which is to stimulate consumer demand, ensure effective sales, attract attention, increase recognition and loyalty, maintain and increase the interest of Participants in the trademarks, products and services of the Organizer in order to further promote them on the market.

2. Organizers of the Promotion

The Organizer of the Promotion is Go Travel Un Limited, a Hong Kong corporation under the number 1658681, legal address: Suite 1504, 15/F, Chinachem Tower, 34-37 Connaught Rd Central, Hong Kong (hereinafter referred to as the Organizer).

3. Participants of the Promotion

3.1 Any individuals, who have reached the age of majority in their home country (hereinafter referred to as the "Participants") can take part in the Promotion.

3.2 Each Participant of the Promotion confirms that they are familiar with these rules, unconditionally and unconditionally accepts their terms and guarantees that they will comply with them during the entire period of the Promotion.

4. General terms and geography of the Promotion

4.1. General terms of the Promotion: from 00:01 minute May 30 2022 to 23 hours 59 minutes August 31 2022.

4.2. The promotion is held on the Internet on the Organizer's website www.wayaway.io and the WayAway application for iOS.

4.3. The Organizer of the Promotion has the right to extend the term of the Promotion or to its early termination by publishing the relevant notice on changes and/or an updated version of the Rules of the Promotion on the [website](#) or by posting information on the pages in their groups on social networking sites.

4.4. The Promotion is held within the framework of the Organizer's product: WayAway Plus subscription. The terms of the WayAway Plus subscription are located [here](#). By participating in the Promotion, Participants agree to the terms of the WayAway Plus subscription.

5. Procedure for participation and holding of the Promotion

5.1. To become a Participant of the Promotion (hereinafter referred to as the Participant), one person must:

5.1.1. Register on the [website](#) or in the WayAway mobile application and subscribe to WayAway Plus.

5.1.2. When subscribing, the cost will be recalculated automatically for all users and will be 49 (forty nine) US dollars instead of 99 (ninety nine) US dollars. The terms of the Promotion can be used no more than 1 time per account from one Participant of the Promotion.

6. Rights and obligations of the Participant of the Promotion

6.1. The Participant of the Promotion has the right to:

6.1.1. Get acquainted with the Terms of the Promotion;

6.1.2. Take part in the Promotion in the manner specified in these rules.

6.2. By participating in the Promotion, the Participant confirms that he is fully familiar with and agrees with these rules.

7. Miscellaneous

7.1. The Organizer of the Promotion is not responsible for any direct or indirect losses of participants associated with participation in the Promotion, including those resulting from failures in telecommunications and energy networks, malicious programs, unscrupulous actions of third parties aimed at unauthorized access and/or disabling the software and/or hardware complex of the Organizer of the Promotion, as well as unforeseen circumstances of a force majeure nature. The Organizer of the

Promotion is not obliged to reimburse the participants of the Promotion in such cases. The Organizer of the Promotion does not cover any expenses of the Participants, including the cost of paying for Internet services, telephone and other expenses that may arise in the process of participation in the Promotion.

7.6. This version of the Rules comes into force at 00:00 on August 10, 2022 (Pacific time) and is valid until the full completion of the Promotion, changes to these Rules come into force, or the cancellation of the Promotion at the initiative of the Organizer.

7.7. Participants are responsible for their actions within the framework of participation in the Promotion. In the event of losses incurred by the Organizer in connection with the Participant's violation of these Rules, the relevant Participant is obliged to reimburse the Organizer for the amount of damage caused by such actions.
